More important than the staff that makes up CRYJ are the teens that make up CRYJ. So often, the question is posed: **"Who is a CRYJ teen?"**

More times than we can count, while explaining CRYJ to someone not familiar, they've replied with something along the lines of "oh, so you work with the bad kids?" It's usually easy enough to brush aside and use as an educational opportunity. The truth is, all of us have made mistakes, as kids, as teens, and as adults. Some of those mistakes have had consequences, and those consequences occur on so many different levels. Some involved disappointment from a family member, some might have caused harm to a friendship or relationship, some might have had financial repercussions. Some mistakes involve law enforcement and the justice system, some don't. Regardless, in moving past a mistake, the opportunity is to repair harm and move forward with dignity. This is where CRYJ comes in.

We prefer to shy away from labels. Any given day seems like a modern-day incarnation of the 1980's film *The Breakfast Club*, where the brainiac, the jock, the outcast, the rebel, and the popular kid come together, learn more about each other, find connection, and move forward in the world as better people.

IMPACT: 2021

Restorative Justice

After 23 years, our bread and butter remains the same: offering teens an opportunity to take meaningful accountability and repair harm outside of the traditional justice system. By holding space for restorative conferences

Youth Empowerment Workshops

Teen workshops regularly happen at CRYJ twice a week. Covering the gamut from risk taking to mental health and coping, this is where youth get a chance to lead the discussion, and address what feels important to them. It's a place to be heard, a place to share, and a place to learn.

School Justice Partnership

5% of participants in 2019, 20% in 2020, and 41% in 2021.... we'll call that momentum! By partnering with administrators and school resource officers, youth are able to participate at CRYJ, spending less time out of school, with first-time infractions completely diverted from the justice system

Teen-in-Residence

But what happens after CRYJ?

For a select few teens (and more into the future!) the opportunity to return to CRYJ as a paid staff member for a three-month period is an opportunity to to take a mentorship role, work a little closer with CRYJ staff, and polish up some leadership skills.

Impact: 2021

Non-Judgement

"I feel like I came in here hard headed and I thought CRYJ was just going to be people yelling at me about what not to do. I would tell someone who's new to this process that it's not just about getting in trouble. It's so non judgemental and things go a lot deeper than you're expecting." - EC

Holding space

My favorite thing about CRYJ is the way we all have respect for each other

Relationships

"My favorite part of CRYJ was the community impact circle. That was the turning point for my relationship with my mom. I think it was good for her to talk to other parents and know she wasn't alone. We hadn't talked to each other like that before, but it didn't end when we left the room. We kept talking that night, and the next day." - AW

Community

"I feel like CRYJ is a very safe place where you have people from your community who are going through the same things you are." - RA

Accountability

Turning 18 has a huge wake up call for me. It has me thinking about the harm I could cause driving drunk differently. But honestly I don't think I could have gotten there without CRYJ." - EC

By the numbers: Prior to CRYJ Participation

Every teen's time at CRYJ is uniquely in response to their individual situation and needs. Not every teen needs to go to a risk-taking workshop on alcohol. Some teens end up having multiple one on one meetings in preparation for a victim-offender conference. Other teens choose to continue to participate after they have completed their program agreement, or engage in CRYJ's new Teen in Residence program.




